Approved Budget for the Contract (ABC) is inclusive of all applicable taxes. Bidders are required to submit bids for all units. Bids received in excess of the ABC for each unit shall be automatically rejected at bid opening.

Delivery of the services is required for a period of thirty (30) calendar days. Bidders should have completed, within the past three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

The Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criteria as specified in R.A. 9184 and its IRR, otherwise known as the Government Procurement Reform Act. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bid Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 otherwise known as “Government Procurement Reform Act” and its Implementing Rules and Regulation (IRR).
